Residency Affidavit

must be updated in the spring of each year

Residency Requirements when the Parent/Legal Guardian ***does not*** own or lease the residence, consists of the following:
The parent/legal guardian must provide **2 proofs** of residency in addition to completing the residency affidavit.
AND The homeowner must provide **3 proofs** of residency.

Residency Requirements

Parent/Legal Guardian: **3 proofs** of residency with parent/legal guardian name and current address are required.
You will need a **notarized** residency affidavit as well as to 2 proofs from Category B.

Homeowner: **3 proofs** of residency in the homeowner’s name with an address within School District 202 boundaries are required, with at least one document from category C and one document from category D.
